 - Members shall not be liable for the debts, contractual obligations or any other liabilities of the golf course and their liability shall be limited solely to the amount due by them in respect of their outstanding subscriptions or other monies payable.
 - Members shall be bound by the Rules issued by the Board of Protea Leisure Limited Trading as Bonanza Golf Club as amended from time to time and displayed in the club house and on the Bonanza Golf Club website.
2. The golf course will not usually disclose a member's personal information to any other person or organisation without the consent of the member or unless there is a legal requirement to do so.
3. Where an email address is provided, the golf course may send newsletters, invitations, advertising material or other promotion communications. By signing this application a member gives consent to such communications but they may withdraw that consent at any time giving written notice to the general manager of the golf club.
4. All persons entering the golf club premises or using the golf club's facilities do so at their own risk and all such persons must be responsible for their own safety and for the care of their belongings. Neither the golf course nor management, employees, agents or contractors shall be liable for any injuries (including loss of life) incurred by such persons or loss or damage to their belongings, whatever the cause.
